ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 18985 to remove a lateral off of the Fort McMurray Transmission Pipeline.

1. Within 90 days of issuance of the AUC approval, ATCO Gas and Pipelines Ltd. shall file with the AUC confirmation that it has filed a OneStop update for Licence 18985 with the Alberta Energy Regulator.
