Gas Utility Pipeline Record Amendment Licence 9793

Licence Update

ATCO Gas and Pipelines Ltd. Forestburg Generating Plant Transmission Pipeline

Proceeding 25931 Application 25931-A001

ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 9793 for the following:

- "To Location" legal subdivision amendment of line 6
- pipe status amendment of line 8 from operating to abandoned
- length amendment of line 8 from 0.08 kilometres (km) to the revised length of 0.07 km
- "From Location" legal subdivision amendment of line 8

The Commission finds the proposed amendment to be necessary and hereby amends Licence 9793 under Section 11 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*, subject to the following condition:

1. Within 90 days of issuance of the AUC approval, ATCO Gas and Pipelines Ltd. shall file with the AUC confirmation that it has filed a OneStop update for Licence 9793 with the Alberta Energy Regulator.
