ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 8488 for the following:

- splitting line 7 into lines 7, 21, 22, 23 and 24
- removal of lines 21 and 23

The Commission amended Licence 8488 under Section 11 of the *Pipeline Act* and Section 4.1 of the *Gas Utilities Act* in Decision 25933-D01-2020<sup>1</sup> subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*, subject to the following condition:

1. Within 90 days of issuance of the AUC approval, ATCO Gas and Pipelines Ltd. shall file with the AUC confirmation that it has filed a OneStop update for Licence 8488 with the Alberta Energy Regulator.
