Appendix 1 to Decision 25944-D01-2020November 4, 2020ATCO Gas and Pipelines Ltd.Proceeding 25944Strathmore East Lateral PipelineApplication 25944-A001

ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 637 for the following:

- splitting line 43 into lines 43, 48, 49, 50 and 51
- removal of lines 48 and 50
- length amendment of original line 43 from 6.68 kilometres to the revised length of 7.23 kilometres

The Commission amended Licence 637 under Section 11 of the *Pipeline Act* and Section 4.1 of the *Gas Utilities Act* in Decision 25944-D01-2020¹ subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*, subject to the following condition:

1. Within 90 days of issuance of the AUC approval, ATCO Gas and Pipelines Ltd. shall file with the AUC confirmation that it has filed a OneStop update for Licence 637 with the Alberta Energy Regulator.
