ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 1829 to delete line 101 as a duplicate of line 55.

The Commission finds the proposed amendment to be necessary for consistency with the Alberta Energy Regulator (AER) database and hereby amends Licence 1829 under Section 12 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*.
