Buffalo Plains Wind Farm

Buffalo Plains Wind Farm Inc. has filed applications for a wind power plant project in the Lomond area

Proceeding 26214

Applications 26214-A001 and 26214-A002

The Alberta Utilities Commission (AUC), the independent utilities regulator, will be considering the power plant development applications in Proceeding 26214. If you feel you may be affected by these applications you can provide input to the AUC to review before it makes its decision. You may be eligible for funding to support your position, which includes costs for legal representation and expert witnesses.

Written submissions are due February 24, 2021.

Buffalo Plains Wind Farm Inc. has applied to construct and operate the Buffalo Plains Wind Farm, under the *Hydro and Electric Energy Act*. The project will have a maximum generation capacity of 514.6 megawatts (MW), consisting of 83 wind turbines with a nominal capacity of 6.2 MW each. The proposed turbines have a hub height of 115 metres, a rotor diameter of 170 metres, and an overall height to blade tip of 200 metres. The project also includes a project substation and overhead/underground collector lines. The potential turbine locations are shown on the map attached to this notice. The project would be located approximately two kilometres west of the village of Lomond in Vulcan County. Specifically, the project area would cover the following sections:

Participation in a hearing

Persons (including individuals and corporations) who have rights that may be directly and adversely affected by the Commission's decision on the applications are legally entitled to participate in a public hearing to consider the applications. This permission to participate in a hearing is referred to as standing, and persons with standing are referred to as interveners.

For the purposes of this proceeding, the Commission generally considers that persons who own or reside on property located within 2,000 metres of the proposed project boundary have rights that may be directly and adversely affected by its decision on the applications and therefore have standing. Persons with standing will be legally entitled to participate in the hearing process if they choose to, and will qualify for intervener funding, which may include costs for legal representation and expert witnesses.

Standing for other participants will be considered on a case-by-case basis. If the Commission receives an objection to a person's request to participate or status as an intervener, the Commission will make a decision on whether the person has standing or is eligible for intervener costs.

All interveners are encouraged to consider whether to hire legal representation, and prepare information requests and evidence, as early as possible. Intervenors with similar interests are encouraged to form groups, as group participation reduces duplication of submissions and costs, and supports an efficient hearing process.

Submissions must include your name, address, phone number, legal land location, description of your land in relation to the proposed development and a description of your interest in the land, your business, or your activities which may be affected by the proposed project. Please also briefly describe the issues you would like the AUC to consider when making its decision.

Privacy

To support an open and transparent process, information you send to the AUC will be publicly available through the AUC’s eFiling System. If there is confidential information you would like to file, a request must be made in advance of filing your submission.

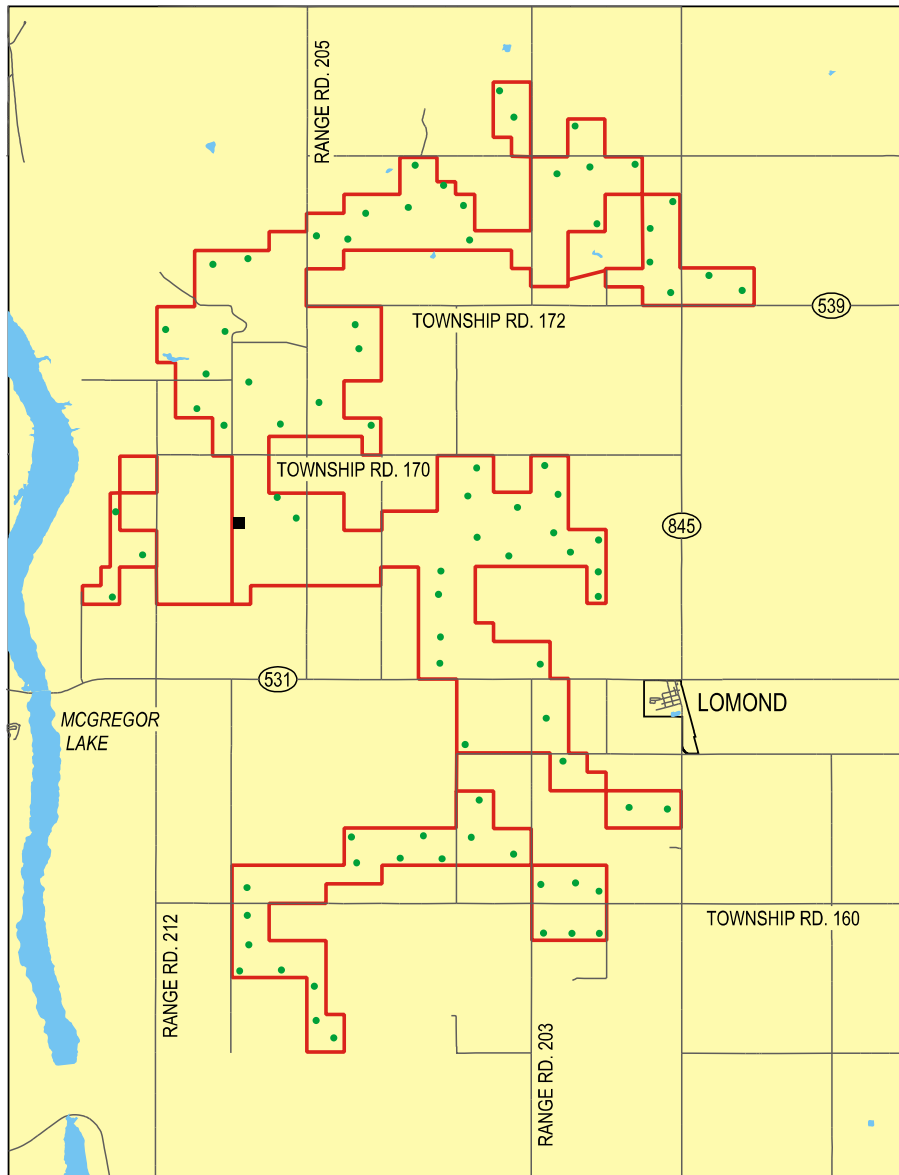
The Commission has established the following process to consider the applications:

Applicant’s deadline to respond to information requests	April 7, 2021
Intervenors’ written evidence deadline	April 21, 2021

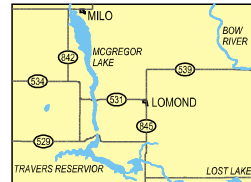
Legend
