

Connection Order 25488-D04-2021

CS Tilley Solar GP Inc. Connect Tilley Solar Power Plant to FortisAlberta Inc.'s Distribution System	Proceeding 25488 Application 25488-A001

C&B Alberta Solar Development ULC (CBA), registered Application 25488-A001 on March 31, 2020, and applied to the Alberta Utilities Commission for an order to connect the Tilley Solar Power Plant to the FortisAlberta Inc. 25-kilovolt electric distribution system. CBA also applied to transfer ownership of the power plant to CS Tilley Solar GP Inc.

The Commission approved the application in Decision 25488-D01-2020,¹ and granted CS Tilley Solar GP Inc. an order to connect the Tilley Solar Power Plant to FortisAlberta Inc.'s electric distribution system in Decision 25488-D02-2021,² pursuant to Section 18 of the *Hydro and Electric Energy Act*. This approval is subject to the provisions of the *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders made under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

1. CS Tilley Solar GP Inc. may connect the power plant to the distribution system in the northeast quarter of Section 13, Township 18, Range 13, west of the Fourth Meridian, as indicated in Application 24434-A001.
2. The specifications of the connection shall be as set out in Application 24434-A001.
3. The connection shall be operated so that except under short-term emergency conditions:
 - (a) The flows of real and reactive power are those for which the connection is designed and which it is intended to carry on a continuous basis.
 - (b) No excessive surges of 60-hertz power or excessive exchange of power frequency harmonics shall occur between the systems connected.

The Commission may cancel or suspend this order, in whole or in part, in accordance with Section 41 of the *Hydro and Electric Energy Act* or may review this order, in whole or in part, upon its own motion or upon an application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*.

The Commission may, within 30 days of the date of this order and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected order on its website.
