## 2016-2018 direct assigned capital deferral account reconciliation application compliance filing

### **Proceeding 26278 AltaLink Management Ltd.**

The Alberta Utilities Commission, the independent utilities regulator, will be considering AltaLink Management Ltd.'s 2016-2018 direct assigned capital deferral account (DACDA) reconciliation application compliance filing to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest. If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

AltaLink filed an application on January 29, 2021, requesting approval for its 2016-2018 DACDA compliance filing to Decision 24681-D01-2020.<sup>1</sup> The application also provides compliance to directions from Decision 25369-D01-2020.<sup>2</sup>

AltaLink stated that its application complied with directions 4-7 of Decision 24681-D01-2020 and directions 1 and 2 of Decision 25369-D01-2020. Directions 1-3 of Decision 24681-D01-2020 would be complied with at the time AltaLink files its next DACDA.

Further, as part of this application, AltaLink requested that the Commission approve the payment of interest in accordance with Rule 023.<sup>3</sup>

### **Written submissions are due February 11, 2021.**
