ATCO Gas and Pipelines Ltd. applied to the Alberta Utilities Commission for an amendment to Licence 5320 for the following:

- splitting line 2 into lines 2, 10, 11, 12 and 13
- removal of lines 10 and 12
- environment code amendment of lines 10 and 12

The Commission amended Licence 5320 under Section 11 of the *Pipeline Act*, and Section 4.1 of the *Gas Utilities Act* in Decision 26240-D01-2021¹ subject to the provisions of the *Pipeline Act*, *Gas Utilities Act* and the *Alberta Utilities Commission Act*, any regulations or orders made under the acts and the Commission rules made pursuant to the *Alberta Utilities Commission Act*, subject to the following condition:

1. Within 90 days of issuance of the AUC approval, ATCO Gas and Pipelines Ltd. shall file with the AUC confirmation that it has filed a OneStop update for Licence 5320 with the Alberta Energy Regulator.
