Notice 2021 performance-based regulation rate implementation

Proceeding 26360 ATCO Electric Ltd. and ATCO Gas and Pipelines Ltd.

The Alberta Utilities Commission, the independent utilities regulator, will be considering the application from ATCO Electric Ltd. and ATCO Gas and Pipelines Ltd. (collectively referred to as ATCO Utilities), for 2021 performance-based regulation (PBR) rate implementation to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest. If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision.

In Decision 26170-D01-2020,¹ the Commission approved ATCO Utilities' proposal to provide rate relief for customers on an interim basis given the current economic situation in Alberta, including the impacts to customers due to the COVID-19 pandemic, and directed the ATCO Utilities to submit an application by March 1, 2021, to address the eventual implementation of the 2021 PBR rates and the treatment of deferred amounts.

As directed in Decision 26170-D01-2020, ATCO Utilities have filed an application requesting approval for 2021 PBR rate implementation application and addressed the following: (i) time period and magnitude of rate relief; (ii) timing and impact of the collection of deferred amounts; (iii) carrying costs; and (iv) rate changes beyond the scope of the distribution rate relief initiative.

Written submissions are due March 10, 2021.

If you do not have access to the internet, send your name, address, phone number, organization you are representing, description of your interest in the proceeding, position including information in support of the position and reasons why the AUC should decide in the manner recommended, and whether further process is required. If no written submissions are received, the Commission may make its decision without further notice or process.
