

Buffalo Plains Wind Farm Inc. Buffalo Plains Wind Farm Proceeding 26214 Applications 26214-A001 and 26214-A002

Correction to map in notice of applications

- 1. The Alberta Utilities Commission, the independent utilities regulator, is considering the power plant development applications in Proceeding 26214. On January 13, 2021, the Commission issued a notice of applications describing the applications, which include requests by Buffalo Plains Wind Farm Inc. to construct and operate a power plant consisting of 83 wind turbines with a nominal capacity of 6.2 megawatts each, as well as a substation and overhead and underground collector lines.
- 2. The notice of applications issued by the Commission included a map identifying the potential turbine locations and certain proposed overhead collector lines.
- 3. The Commission has identified an error on the map included in the notice of applications. The map inadvertently omitted a proposed overhead collector line running north-south, parallel to Range Road 211, on the west side of the project.
- 4. A corrected version of the map indicating the location of the previously omitted overhead collector line is included below:



- 5. The existence and location of the overhead collector line was included by Buffalo Plains Wind Farm Inc. in its participant involvement program and application materials. The Commission notes that some project infrastructure, including underground collector lines, is not depicted in the above map, but is described in the application materials on the eFiling System on the AUC website.
- 6. Any person who, having had the opportunity to review the corrected map, feels they may be directly and adversely affected by the Commission's decision on the applications may register to participate in the proceeding by April 5, 2021, as described in the attached revised notice of applications.
- 7. The Commission notes that persons who have already registered to participate in this proceeding are not required to re-register or to re-file any of the information they may have previously filed with the Commission, but they may notify the Commission by April 5, 2021, if they feel that their submissions on the project have changed as a result of the corrected map.
- 8. The Commission also wishes to advise the applicant and registered participants that the process schedule has been suspended and a determination on any future process steps will be issued in due course.

Revised - Notice of applications Buffalo Plains Wind Farm

Buffalo Plains Wind Farm Inc. has filed applications for a wind power plant project in the Lomond area

Proceeding 26214 Applications 26214-A001 and 26214-A002

The Alberta Utilities Commission (AUC), the independent utilities regulator, is considering the power plant development applications in Proceeding 26214. If you feel you may be affected by these applications you can provide input to the AUC to review before it makes its decision. You may be eligible for funding to support your position, which includes costs for legal representation and expert witnesses. The Commission distributed a notice of applications on January 13, 2021, and is distributing this revised notice to correct a mapping error.

Written submissions are due April 5, 2021.

Buffalo Plains Wind Farm Inc. has applied to construct and operate the Buffalo Plains Wind Farm, under the *Hydro and Electric Energy Act*. The project will have a maximum generation capacity of 514.6 megawatts (MW), consisting of 83 wind turbines with a nominal capacity of 6.2 MW each. The proposed turbines have a hub height of 115 metres, a rotor diameter of 170 metres, and an overall height to blade tip of 200 metres. The project also includes a project substation and overhead/underground collector lines. The potential turbine locations and overhead collector lines, including a previously omitted collector line are shown on the corrected map attached to this notice. The project would be located approximately two kilometres west of the village of Lomond in Vulcan County. Specifically, the project area would cover the

Participation in a hearing

Any person who, having had the opportunity to review the corrected map, feels they may be directly and adversely impacted by the Commission's decision on the applications may register to participate in the proceeding. The Commission notes that persons who have already registered are not required to re-register or to re-file any of the information they may have previously filed with the Commission, but they may notify the Commission if they feel that their submissions on the project have changed as a result of the corrected map.

Persons (including individuals and corporations) who have rights that may be directly and adversely affected by the Commission's decision on the applications are legally entitled to participate in a public hearing to consider the applications. This permission to participate in a hearing is referred to as standing, and persons with standing are referred to as interveners.

For the purposes of this proceeding, the Commission generally considers that persons who own or reside on property located within 2,000 metres of the proposed project boundary have rights that may be directly and adversely affected by its decision on the applications and therefore have standing. Persons with standing will be legally entitled to participate in the hearing process if they choose to, and will qualify for intervener funding, which may include costs for legal representation and expert witnesses.

Standing for other participants will be considered on a case-by-case basis. If the Commission receives an objection to a person's request to participate or status as an intervener, the Commission will make a decision on whether the person has standing or is eligible for intervener costs.

All interveners are encouraged to consider whether to hire legal representation, and prepare information requests and evidence, as early as possible. Interveners with similar interests are encouraged to form groups, as group participation reduces duplication of submissions and costs, and supports an efficient hearing process.

Privacy



Process schedule

The Commission has suspended the process schedule set out in the original notice of applications. The revised process schedule will be communicated at a later date. Any written submissions in response to the mapping error are due April 5, 2021.
