eReserve4 Battery Energy Storage Project

TERIC Power Ltd. has filed an application to construct and connect a power plant in the Municipal District of Provost No. 52

Proceeding 27234
Application 27234-A001

The Alberta Utilities Commission (AUC), the independent utilities regulator, will be considering the power plant development application in Proceeding 27234. If you feel you may be affected by this application you can provide input to the AUC to review before it makes its decision.

Written submissions are due May 5, 2022.

TERIC Power Ltd. has applied to construct and operate a 20-megawatt battery energy storage facility, to be designated as the eReserve4 Battery Energy Storage Project. The power plant would be located in the northeast quarter of Section 9, Township 42, Range 9, west of the Fourth Meridian, approximately eight kilometres southeast of the town of Hardisty. TERIC also applied to connect the proposed battery energy storage power plant to the Alberta Interconnected Electric System via the FortisAlberta Inc. electric distribution system. The application has been filed under the *Hydro and Electric Energy Act*.

TERIC has applied for a 20-megawatt battery energy storage power plant, to be designated as the eReserve6 Battery Energy Storage Project, which is proposed to be located adjacent to the eReserve4 Battery Energy Storage Project in the same land location. The Commission is considering the eReserve6 Battery Energy Storage Project in Proceeding 27236.

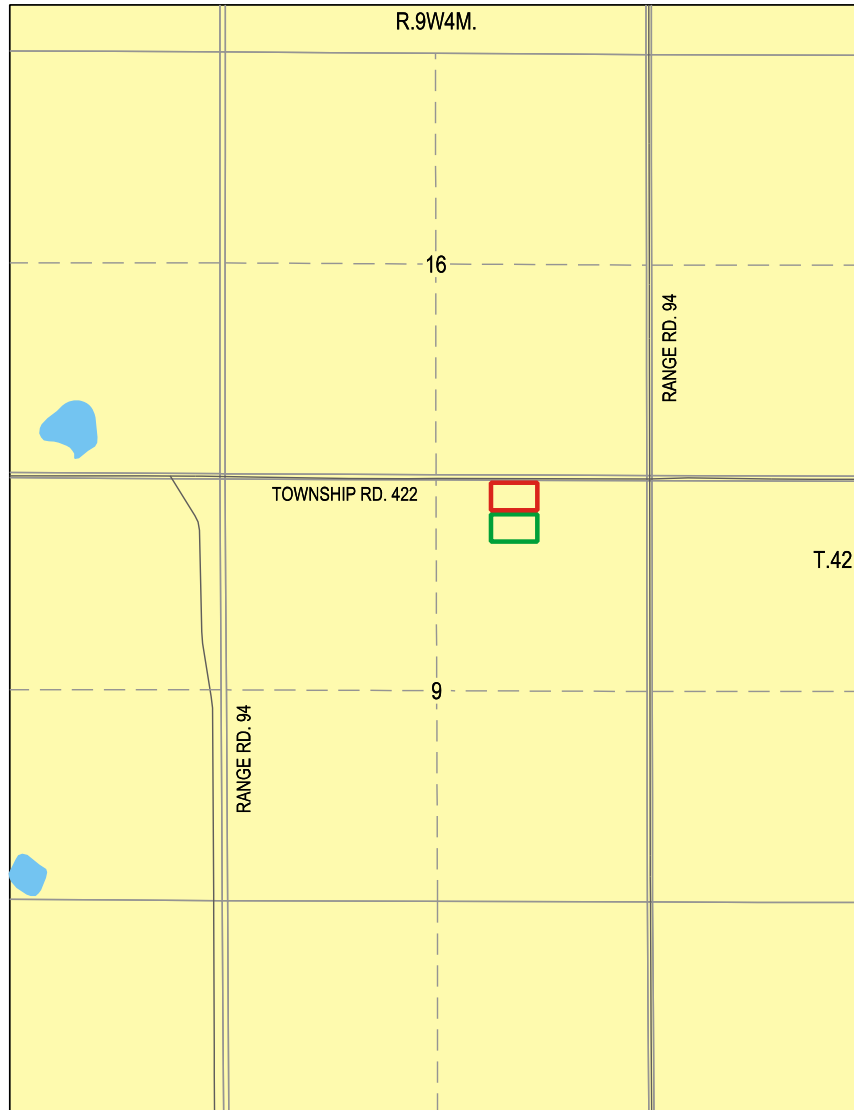

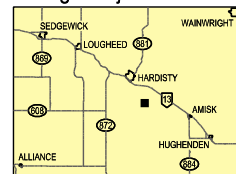
Legend
